They must reside in Washoe County, for a minimum of one year, as well as having had continuous employment for a minimum of two years. TMHH families who buy our homes are required as part of their partnership to invest 500 hours of "sweat equity" in the construction of their home and other projects.

By bringing together volunteers, experienced help, suppliers, city government agencies, and families to form partnerships, Habitat creates an atmosphere that builds homes, dreams, and a strong community.

What projects is TMHH working on in our community?

Currently, we are working on a site on Mt. Charleston Street in Stead. This project, when completed, will have 13 new homes built especially for Habitat families.

How can I become a volunteer or make a donation?

The Truckee Meadows is one of the fastest growing communities in the Western States. Gaming and tourism, the main stay of the Counties economy, rely on a high percentage of minimum wage jobs, which creates an ever-growing need for affordable housing.
